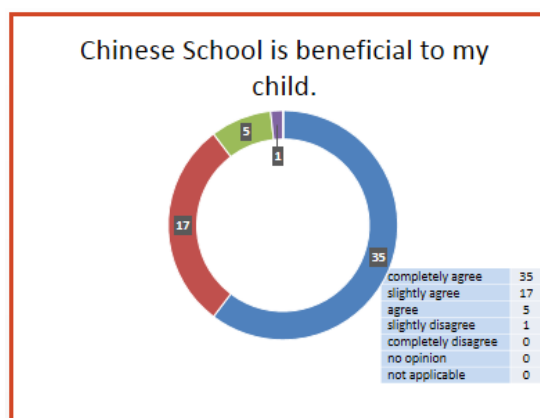
Another change benefiting both the school staff, teachers and the students, the school day will be from 8:00 AM to noon, with class periods duration changed to about one hour increments.
